3. Budget Transfers

5. **New Transportation Contract for 2015/16 School Year per Northwest Nassau Transportation Cooperative**

5.1 **WHEREAS**, the Northwest Nassau Transportation Cooperative issued a bid for cooperative transportation services on August 6, 2015, and

WHEREAS, the Northwest Nassau Transportation Cooperative awarded such bid to the low bidders for each bus route on August 13, 2015, and

WHEREAS, the Carle Place Union Free School District will participate in these transportation services, now therefore

BE IT RESOLVED, that the Board of Education authorizes the District to enter into a transportation contract and authorizes the Board of Education President to execute same for the 2015/16 school year based upon the low bidder identified through the Northwest Nassau Transportation Cooperative award for the attached school and contractor.
